We have provided this privacy policy to help you understand how we collect and use your personal information when you use our website or take advantage of our services, either online, in branch, or over the phone.

Scope of this policy

Our websites only

This privacy statement applies to all websites, domains, services and applications operated by Andrew Purnell & Co.

You should also be aware that communications over the internet, such as e-mails, are not secure unless they have been encrypted. Your communications may route through a number of countries before being delivered – this is the nature of the internet. Andrew Purnell & Co cannot accept responsibility for any unauthorised access or loss of personal information that is beyond our control.

Personal information supplied via property portals or search engines will not be covered by this privacy statement. Information relating to you and the care we take with it.

Collection of data

Andrew Purnell & Co will acquire anonymous and personal information relating to you in the following ways, i.e. by:

- 1. Automatic means, as with cookies.
- 2. Voluntary means, as when you provide the information to us.
- 3. Recording of calls via property search portals.

What are cookies?

Cookies are created when your browser loads the website. The website sends information to the browser which then creates a text file. Cookies are stored on your device for various periods of time, from as short time as the duration of your browsing session to several months.

Every time you come back to the website, the browser retrieves and sends cookies to the server, which helps to improve your experience of the website by:

- Remembering settings, so you don't have to re-enter them every time you visit.
- Remembering your last properties and searches, helping you to keep on top of new listings.
- Measuring use of the website so that we can see where we can improve.

You can manage and/or delete these small files from your device, but please be aware that this will limit the functionality that we are able to offer to you.

What cookies do we use?

The Andrew Purnell & Co website uses cookies that can be divided into the following two groups:

STRICTLY NECESSARY COOKIES

Strictly necessary cookies allow you to log into your account and view account details without a need to log in again every time you navigate to subsequent page.

- Andrew Purnell-Sessions Stores information about whether you are logged in into your account or not.
- Visit-secure token (session) Stores information necessary to access your account.

VOLUNTARY COLLECTION

Andrew Purnell & Co may acquire personal information from you voluntarily, for example, when you:

- Speak with us on the telephone.
- Sign up for property alerts and other material.
- Make an enquiry or complaint.
- Complete an application form to register, rent, let buy or sell a property.
- Enquire into block management.
- Purchase a product or service.

Obtaining from another group member

An employee of Andrew Purnell & Co collecting information about you may share it with another internal colleague, but only for the uses described in this privacy statement, in order to progress an agreed service.

Third party sources

Andrew Purnell & Co maybe provided with personal information from voluntary sources for the information of referencing which will be provided and processed with individual's consent. The information we collect may be used along with the information we have obtained by the other means mentioned in this privacy statement.

How we use your information

First and foremost, we use information about you to provide a service. Whether you registered to look for a property which results in taking a let/purchasing a property, or you wish to sell/rent, the information provided by you is used with your consent to process your move.

Information provided for block management purposes will be used to process service charge statements, budgets, contractor visits and to make and receive payments. This information will not be shared with third parties for marketing purposes.

We will hold your information when registering a property search in order to contact you with newly listing properties we feel are suitable. We do not share your information at search stage; you will only be contacted by e-mail or phone if we have a property for you/wish to discuss your property search. You may opt out at any time, deleting your details manually using our 'opt out' link or by calling us to action your request.

We may use information provided by you with your consent to progress referencing. This information will be shared with your landlord for their information only in the interest of transparency. You will be advised prior to supplying your references upon who we may share.

With your authorization or at your request we may share your contact details with utility providers in order for them to provide tariffs and products of interest. As previously stated we cannot be accountable for how they share your data or for which suppliers contact you if you choose to take a relationship with a utility provider.

In the interested of dealing with any maintenance issues as quickly as possible your details maybe passed to a contractor to organise access should you report a maintenance issue. Should you advise you would not like your details to be shared we will be happy liaise.

And finally, we may use the information to comply with the law, to correspond with our regulators, and to combat fraud and other crime.

How we share your information

Andrew Purnell & Co will not sell, rent or lease your personal information for commercial gain to others outside the group.

We retain service providers, contractors and suppliers to manage or support our business operations, regulated and unregulated, to provide the product and services bought or commissioned from us and to assist us with marketing and communication initiatives. All providers are required by contract to keep the information confidential and secure and to use it only to carry out the services being performed.

We will not otherwise share the personal information you provide without your permission, unless to:

- 1. Respond to information requests of police and governmental authorities.
- 2. Comply with any law, regulation, or court order.
- 3. Investigate and help prevent security threats, fraud or other malicious activity.
- 4. Enforce/protect the rights and properties.
- 5. Protect the rights or personal safety of Andrew Purnell & Co and its employees and customers.
